Bihar Judiciary Syllabus, Prelims and Mains

- The Preliminary Examination includes questions from General Knowledge, Current Affairs, Elementary General Science, Constitutional and Administrative Law of India, Hindu Law & Muhammadan Law, Law of Evidence and Procedure, etc.
- The main examination includes five compulsory papers: General Knowledge and Current Affairs, General Hindi, General English, Elementary General Science, and Law of Evidence and Procedure.
- Whereas you must choose three optional papers out of five law subjects.

Bihar Judiciary Prelims Syllabus 2023

The Bihar Judiciary Prelims Exam is an objective examination comprising two papers: Paper 1: General Knowledge & Paper 2: Law. General knowledge is conducted for 100 marks, and law paper is conducted for 150 marks.

Bihar Judiciary Syllabus 2023 for General Knowledge

The Bihar Judiciary Syllabus 2023 for General Knowledge evaluates a candidate's awareness of current affairs, knowledge of prominent events, and significant information in various fields.

Although, the BPSC doesn't mention the in-depth syllabus for the General Knowledge Paper. It would be best to focus on the following common topics asked in other state PCS exams to enhance your Bihar Judiciary GK preparation:

1 - History of India

You must be familiar with the broad aspects of the history of Bihar, including the following topics:

- Ancient and Medieval Indian History
- Modern Indian History

- Indian national movement
- Indian Constitution and Polity
- Landmarks in world history
- World Wars and their Impact on India
- Post-Independence Consolidation and Reorganization of States in India
- Social and cultural history of India
- Economic and political changes in India after independence

2 - Indian Polity and Economy

Questions of Indian Polity and Economy test knowledge of the country's political system, Panchayati Raj, Community Development, and planning in India and Bihar.

Focus more on the Indian Polity and Economy and significant changes in the economy of Bihar in the post-independence period.

Indian Polity:

- Constitution of India: Preamble, Fundamental Rights and Duties, Directive Principles of State Policy, Union and State Legislatures, Judiciary, Executive, and Electoral Systems.
- Centre-State relations, Inter-State relations, Emergency Provisions, and Constitutional Amendments.
- Public Administration and Governance, Indian Political System, Political Parties and Pressure Groups.
- Local Self-Government and Panchayati Raj System.

Indian Economy:

- Basic concepts of Indian Economy, National Income Accounting, GDP, and GNP.
- Poverty, Unemployment, and Inflation in India.
- Indian Agriculture, Industry, and Service sector.
- Indian Banking and Financial System, Fiscal Policy, and Monetary Policy.
- International Trade and Balance of Payments.

3 - Geography

- In Geography, the emphasis will be on the geography of India and Bihar.
- Questions on the Geography of India and Bihar will relate to the country's physical, social, and economic Geography, including the main features of Indian agricultural and natural resources.
- You must know about Bihar's geography, geographical division, and major river systems.
- Here is a list of topics that are commonly included in the syllabus for geography:
 1. **Physical Geography:** Earth, Atmosphere, Hydrosphere, Biosphere, Lithosphere, Climatology, Oceanography, etc.
 2. **Environmental Geography:** Biodiversity, Environmental Hazards, Environmental Management, and Sustainable Development.
 3. **Cartography:** Map-making, Types of Maps, Map Projections, and Remote Sensing.
 4. **Geographical Techniques:** Fieldwork, Surveying, Geographical Information Systems (GIS), and Statistical Techniques.

4 - Indian National Movement

- Questions on the Indian National Movement will relate to the nature and character of the nineteenth-century resurgence, growth of nationalism, and attainment of Independence.
- You must answer questions on Bihar's role in India's freedom movement, including the following:
 1. Introduction to the Indian National Movement and its historical significance.
 2. The factors that led to the rise of the Indian National Movement.
 3. Important events and personalities associated with the Indian National Movement, such as the Revolt of 1857, the Swadeshi Movement, the Non-Cooperation Movement, the Quit India Movement, and more.
 4. The role of various organizations and leaders in the Indian National Movement, such as the Indian National Congress, Muslim League, Bhagat Singh, Mahatma Gandhi, and others.
 5. The impact of the Indian National Movement on India's struggle for freedom, including the emergence of nationalism, cultural renaissance, and economic reforms.

6. The legacy of the Indian National Movement and its relevance to contemporary Indian society.

5 - General Science

- Questions on General Science cover general appreciation and understanding of science, including everyday observation and experience, as may be expected of a well-educated person who has not made a particular study of any scientific discipline.

The following are the five compulsory subjects, along with the marks for the Bihar Judicial Service Exam 2023:

- General Knowledge & Current Affairs: 150 marks
- Elementary General Science: 100 marks
- General Hindi: 100 marks
- General English: 100 marks
- Law of Evidence and Procedure: 150 marks

The level of this paper is the same as that of Hindi intended for the aspirants studying Hindi continuously from the fourth class of the Bihar School Examination Committee's secondary examination.

The questions examine your general ability to express the expressions clearly and accurately in simple Hindi and your intuitive understanding of simple Hindi on familiar subjects.
