You will be shortlisted for the Mains examination based on your performance in the prelims exam. So, you must pay special attention to the prelims syllabus and preparation for Madhya Pradesh Civil Judge Exam.

MP Judiciary Syllabus of interview

The final round of the MP Judiciary state will be the personality test interview round, known as viva voce. This stage of the exam carries a maximum mark of 50.

The conducting body will display the final rankings based on the marks of the main examination and the viva-voce.

Note: No matter how much you score in the main examination, you will not be selected for recruitment unless you clear the personality test round and secure the minimum cut-off marks.
